# **Rationale:**

At the 2015 NOHA Annual General Meeting, the NOHA Board of Directors asked for support from the membership to conduct a review of the NOHA Constitution so to comply with the Ontario Not-for-Profit Corporations Act, while also simplifying and creating a better understanding of the Constitution.

The membership supported the first step of the process, which allowed us to implement new By-Laws for the NOHA. Over the last several months, the NOHA has worked to re-organize the Regulations into a clearer and more concise document, while also moving the old By-Laws that remained in effect through this transition period into the appropriate section of the Regulations. Several documents have been made available to the membership which show all the changes that have been made to the Constitution, along with the rationale for any changes or deletions. It is important to note that all changes that have been made in the document do not change the intent of any of the rules.

Moved/Hugh Riddle – Garson Seconded/Claudette Myre – Azilda

**Hugh Riddle – Garson** – This process began at the AGM in 2015 and the analogy that was used last year, which still holds true, is the Constitution is a tree. Last year we established the trunk of the tree, and this year we're asking your support in dealing with the branches. One of the things we tried to do this year was to ensure we were dealing with an informed membership, and so a lot of time and effort was put into making sure the documents were sent out with explanations well in advance. Last year we approved the By-laws, some of those will become Regulations this year. We looked at the Regulations currently in the Constitution, some of which have been around for 98 years, so we've tried to bring some of the language into the current year without changing any of the intent, and some of them are renumbered. We're looking for your support with these. We're not complete, there's still work to be done, following the analogy of the tree, next year would be the leaves of the tree, so there's still some reorganization. My good friend John has volunteered to continue that process. If there's something that is really bothering you in this, please bring it forward and we can address it at this meeting, or we can look at it another time. John will help if you have questions or need explanations, he's the lawyer. I can't thank John enough for the assistance he's provided for the last couple of years. He has graciously donated hours of his time, so thank you.

John D'Agostino – North Bay – As we've touched on last year we've really tried to stick true to the spirit and intent of what was in hand in the past in terms of the Constitution, we've tried to separate critical or fundamental items from regulatory or procedural items that might not need to be voted on at the constitutional level. Step one we completed last year in Timmins, step two is a clarification of the regulations and some of the rules. We're on our way to thinning out, clarifying, and modernizing our Constitution. We should be very proud of it; it's very cutting edge now. Jason and Hugh spent an enormous amount of time going through every word in that Constitution, so thank you. Hugh touched upon the continued refinement process, step three, it's a living tree and it will grow and expand. We want the membership to be involved. Please continue to review it, if you find something that's not right, please let us know. We want to

Steve Vachon – Timmins – Looking for clarification on Regulation 2.2. I haven't had a chance to look at the OHF book, but what we're proposing here is the current wording which was revised at the 2002 AGM states that "All NOHA... by the branch. We're deleting this completely and stating the boundaries of the NOHA. If the OHF Constitution is saying the boundaries of the NOHA are this, I don't believe that covers the actual regulation. Jason Marchand – R.2.2 says all NOHA Teams are located in the NOHA territory. There is also an error on 3.3b of the new numbering, registering for House League Team registration date. The date says August 15th where it should be October 1st. It was an error on our behalf.

# **Change to Read:**

All Leagues of two or more Associations and/or Single Entry Teams that participation in a season schedule must provide to the NOHA their list of Board of Directors, contact information, League schedule and rules and regulations/constitution.

## **Rationale:**

There are currently Leagues within the NOHA that do not register with the NOHA. There is a rule that requires Leagues that wish to have voting privileges to provide information to the NOHA. This proposed amendment has been submitted so that the NOHA is aware of all Leagues that are in existence within our boundaries. This By-Law will be placed into the Regulations of the NOHA if approved.

**Hugh Riddle** – **Garson** – The Rationale explains everything, it's just to have correct information.

**Joe McColeman** – **Sudbury** – Concerning schedule approval, we used to go through Council Directors. Will it be going to the NOHA now? What is the process for scheduling?

# **Presently Reads:**

R.1.1. Teams will be registered in divisions, sub-divisions and categories by the Northern Ontario Hockey Association Board of Directors in the following order:

Senior A
Junior A and B
Juvenile AAA, AA, A, B, C, and D
Juvenile to Novice BB, CC, if applicable
Midget AAA, AA, A, B, C, and D
Bantam AAA, AA, A, B, C, and D
Peewee AAA, AA, A, B, C, and D
Atom AAA, AA, A, B, C, and D
Novice AA, A, B, C, and D

That a local Association, club or single entry team be allowed to enter a second team into a category of a lower classification than guided by that municipality's population, with the approval of the NOHA Executive.

R.1.4. Minor Hockey teams in each age division will be classified into "AAA", "AA", "A", "B", "C", "D" categories by the Northern Ontario Hockey Association Board of Directors. After considering all factors, teams are classified as to calibre with other conditions involved including ice conditions, minor hockey organizations and population. Population figured for each series used as thumb rule only, are approximately as follows:

"AAA" - Open; "AA" - over 35,000; "A" - 10,000-35,000; "B" - 5000-10,000; "C" - 3000-5000; "D" - under 3000.

The NOHA Board of Directors will revisit the populations for all Associations every five years starting in 2012.

# **Change to Read:**

Teams will be registered in divisions, sub-divisions and categories by the Northern Ontario Hockey Association Board of Directors in the following order:

Juvenile AAA, AA, A, B, C, and D
Juvenile to Novice BB, CC, if applicable

Classification is based on a number of factors, including population, player registration history, the number of other minor hockey organizations in the region and other pertinent information which may impact the calibre of an Association or Team.

Population figures for each series used as thumb rule only, are approximately as follows: "AAA" – open; "AA" – over 35,000; "A" – 10,000-35,000; "B" – 5,000-10,000; "C" – 3,000-5,000; "D"; under 3,000.

The NOHA Board of Directors will revisit classification for all associations every five years.

Where a change of classification is being considered, due notice will be provided to the member association and consultation made by the NOHA Board of Directors.

An Association, or Single Entry team will be allowed to enter a second team into a category of a lower classification than guided by that Association's classification, with the approval of the NOHA Executive.

Requests from Associations to change classifications of teams outside of the five-year time frame must be presented with all pertinent information to the NOHA Board of Directors by September 1 of any given season.

## **Rationale:**

It has previously been said that population is only one factor for determining the classification of an Association, however based on R.1.1., it is ultimately the only factor that is looked at. Given that R.1.1. and R.1.4. deal with Association and Team registration, we have proposed merging them.

The proposed change also allows the NOHA Board of Directors to deal with requests outside of the five-year time frame where it would be in the best interest of the NOHA and the participants within an Association to be classified into a different category.

Moved/Claudette Myre – Azilda Seconded/Hugh Riddle – Garson

**Claudette Myre** – **Azilda** – The NOHA Board has received requests in the past to reclassify. This change will allow the Board to deal with these requests if documentation is brought forward.

**Jim Lecappelain** – **North Bay** – I thought the gist of this was we would address the top category, not the lower category, which is what I'm bringing forth in the fourth motion. Here you're passing that top AA category and dropping down to an A, B, or C level, which is a concern of mine.

**Hugh Riddle** – **Garson** – We're trying to address is situations that have arisen that we could have serviced better if we had a little more latitude. There have been situations here and in the Timmins area with a AA Team before an A Team, and sometimes the AA Team doesn't suit the best interests of where or how to play. By approving this, it gives the Board more discretion if, say Timmins wants to run four Novice A Teams instead of one AA and three A, this provides us with the discretion when the rationale is brought forward as to why we don't have to go strictly by population. We're trying to help situations that have arisen in the past where we may not have had favourable press. It's just to allow that latitude.

**Jim Lecappelain** – **North Bay** – In this paragraph you're referring to the second Team. I thought the objective here was we would look at the primary Team. The rebuttal that has been given to other Associations, you're not referring to the application for a AA Major Team but a secondary Team underneath. I feel it's important that Associations not be forced to put forward a Team they can't.

**Jason Marchand** –That sentence is still there, but this allows the Board to reclassify the main team. The last sentence is key, so if your primary Team is A, then your secondary Team could be reclassified as B, C, etc. So if West Ferris feels they should be classified as A, that allows the Board to deal with it when you provide your rationale for asking for reclassification.

**Jim Lecappelain** – **North Bay** – It doesn't really spell that out. The primary Team was my concern.

**Jason Marchand** – But the last sentence in the motion, in dealing with requests for reclassification, that's the key. Right now the classification is looked at every five years, and we get requests similar to what you explained where Timmins wants four Novice A Teams, West Ferris wants A Teams versus AA Teams, and the Board has been bound by that five-year timeframe, so this allows them to look at those situations outside that timeframe once you provide rationale.

**Jim Lecappelain** – **North Bay** – It is my understanding that if this moves ahead, then my motion won't be looked at.

**Dick Farrow** – **Moderator** – Yes, so are you okay with that, do you wish to make an amendment to the motion that's on the floor?

**Jim Lecappelain** – **North Bay** – I really feel that Motion #4 addresses this issue more directly. My proposed motion is focused on a lot of hockey centres made up of different Associations. When multiple Associations make up a centre, this causes a lot of problems, but when you have you have an Association with a AAA team, then West Ferris must bring forward a AA Team. If we don't have the kids or the ability, then why should be forced to do it. We should have a more direct avenue out.

**Dick Farrow** – **Moderator** – Does this motion deal with their concerns?

**Jason Marchand** – I believe it does. The only difference is ours addresses all the Associations in Northern Ontario, so for example if there's a C Centre and they don't feel they are a C Centre, they can request to the Board to be a D Centre, so it applies to everyone, and the other issue the West Ferris motion has is that it takes the authority from the Board to make a decision based on what is the best for hockey in Northern Ontario, and conflicts with another regulation that does say that. It's not guaranteed to get approval, however if the rationale is brought forward, the Board would review it. Because of that rule in the past, the Board has not been able to handle the small amount of situations involved.

**Richard MacDonald** – **New Liskeard** – The only thing I have questions about regarding this motion is there is no timeline. Is there a timeline, because we see Teams that participate that shouldn't be there as A or House League, and we want to respect the dignity of those kids. **Jason Marchand** – The date in the motion is September the 1<sup>st</sup>, with the reason being that our first Board meeting is usually the weekend after labour day so that would allow these requests to be dealt with.

**Richard MacDonald – New Liskeard – Isn't that a little early?** 

**Jason Marchand** – It's meant to be a general thing, not necessarily year to year, and at that point most of our Rep Teams would have some sort of skate to know where they're at overall. **Jim Lecappelain** – North Bay – Jason addressed about 50% of my concerns. I think it's too open, which is not in the motion I've put forth. I think the NOHA should trust our Associations. If we feel we don't have the players and the ability, then why should be forced to go ahead? I think that call has to come from the Association as long as we provide a basis for that saying why we are making this decision.

**Hugh Riddle** – **Garson** – It works the other way as well. We have Associations that are not, by population, AA who wish to be AA, and they provide the rationale for that. What we're trying to address here is the situations presented to us over the last couple hockey seasons, and we're trying to help and promote teams by allowing the flexibility to approve those Teams without going strictly by population. In Timmins, for example, they would like to create an internal league where they have four Teams that are the same and not need to make one of them a AA Team. We're asking to be able to support those requests that come to us from the membership. If you support this, then we have the ability to deal with those situations. That's why we've crafted this. We're looking for a mechanism to support what we're trying to do, and all we ask is that you give us the information required to make that decision. It doesn't affect Tournament of Champions, but the initial carding and building competitive Leagues without people travelling large distances.

**Steve Vachon** – **Timmins** – If we want to host a AAA Team over AA, if we apply on June 1<sup>st</sup>, will we need to wait until the September Board meeting to get the response?


**Jason Marchand** – September 1<sup>st</sup> is the date because that's when Rep Teams are required, but hockey has become a twelve-month sport, so our Board has conference calls over the course of the summer, so if there are enough situations to deal with, I believe we could deal with those types of requests over the summer.

**Steve Vachon** – **Timmins** – The way I see it, the difference between the motions is West Ferris wants certainty that if you have a AAA Team specifically, it's automatic to have an A Team as your next, while this motion doesn't have that automatic, there's a chance the Board will not approve it.

**Dick Farrow** – **Moderator** – Exactly.

Dave Shaw – Timmins – I appreciate the motion, and I understand where it's coming from, and there are a couple things I don't think we're capturing, but I think we want to. For our Novice program we've made completely balanced Teams to create a League. We are required to have one of those Teams as AA, but we don't play NOHA AA at all. The weaker Novice Team ends up being classified AA so they can affiliate up to Atom, so I would like this motion to be clear that it's in regard to the primary Team, and for the second Team, does this apply just to the secondary Team, or does is apply to both the primary and secondary? I would suggest a few things: where a change in classification would be considered, if you can specify both Association and Team classification, what I think is missing is how would we make that decision? I would suggest two things, that you add "where a change of classification is being considered for an Association or a Team." And how will we make this decision? We don't want sand-baggers. We want players playing at the level they should. I suggest adding something in here for the criteria, the rationale of that decision.

**Dick Farrow** – **Moderator** – Are you making an amendment to Motion #3? **Dave Shaw** – **Timmins** – Yes I am. I would suggest that on page 4, where "A change of classification is being considered for an Association or a Team, due notice will be provided." I

would also suggest that instead of "by September 1st" it be "No later than September 1st." So that means we can apply earlier.

**Dick Farrow** – **Moderator** – Please just give the wording to the Amendment of this Motion. **Dave Shaw** – **Timmins** – "Where a change in classification is being considered by an Association or a Team," and then the first paragraph above rationale: "Requests from an Association to change the classification of a Team, blah blah blah, give the information to the Board of Directors no later than September 1<sup>st</sup>." Keeping in mind calibre of players, and the spirit of development. I'll add a last paragraph "These requests will be considered keeping in mind Association's player number, calibre of players, in the spirit of development."

**Jason Marchand** – If I can address that, Dave, the first paragraph on the page says: "Classification is based on a number of factors, including population, player registration history, the number of other minor hockey organizations in the region and other pertinent information which may impact the calibre of an Association or Team." So that covers the rationale and what they're going to be looking at.

**Dave Shaw** – **Timmins** – It includes the facts, but not on what basis a decision will be made. **Richard MacDonald** – **New Liskeard** – The amendment I heard didn't change anything, it didn't say anything new.

**Dave Shaw** – **Timmins** – It didn't say anything new based on an interpretation, so I think that amendment will clarify it.

# **Friendly Amendment**

Moved/Dave Shaw – Timmins Seconded/Jamie Roach – Timmins

"That where a change of classification is being considered for an Association or a Team, due notice is provided...no later than September 1<sup>st</sup>. These requests will be considered by the NOHA Board keeping in mind an Association's calibre, number of players, and including population, player registration history, the number of other minor hockey organizations in the region and other pertinent information which may impact the calibre of an Association or Team."

#### **DEFEATED**

George Suzster – Callander – When I look at that motion, is an Association or Single Entry Team may enter a second. If you're classified as a AA Centre, does that mean you still have to have a AA Team? Or should this motion actually be "an Association entering a primary team?" Jason Marchand - The last paragraph deals with a request for reclassification, so if East Nipissing as an "A" Centre don't feel they're "A" calibre, they can request to be "B", "C", or "D". If you have a second rep Team, you can have a second Team at the same or lower.

**George Suzster** – **Callander** – We're always told by the NDHL League that our Associations are classified at a certain level, and they have to have a Team at that level before they can ice a Team at the lower level. So I think the difference with West Ferris's motion, you could have different Teams at the "A" level and maybe the "B" level.

Jim Lecappelain – North Bay – All I wanted to do here was to establish that all Associations have options. The whole objective here is to be fair with this. If an Association can't put forward a Team, I don't feel that Association should be handicapped, or need to apply and put themselves in a position where their destiny is controlled by a group of people. I feel that Associations know they can't field a Team at that level and shouldn't be told what to do. If you are stuck at a AA level, then you're handicapped at any tournament. The route for my motion is that we're open enough and trust Associations and give them the right to control our Associations so they can enjoy the sport, and that's the rationale.

Bryce Kulik – South Porcupine – The NOHA Board's Motion addresses your concern, and it addresses your concern as well, and it's very simple. For one, you have to go through the NOHA Board to get approval, and for the other it's automatic, and it shouldn't be automatic, and just for the reasons you said, because people are going to sandbag. Does the NOHA Board trust your Association? Sure, they do, but we're getting carried away. At one time you had to have a Major AA Team to have a Minor AA Team, and this will address that. If West Ferris wants to have a Minor Team, they don't have enough kids to have a Major Team, then the NOHA Board will look at it with the appropriate information that will be provided by the Association, and it says that right in the motion. All your concerns will be addressed in the NOHA's Motion, but you still need to go through the Board which you should be. If the information isn't there, it won't be approved.

The NOHA Board of Directors will revisit the populations for all Associations every five years starting in 2012.

#### **Rationale:**

The Initiation Program recommends a ratio of 4:1 Instructor to Player. We recognize that it can be difficult to recruit volunteers, while also acknowledging the importance of the Initiation Program and ensuring that there are enough people to help in the delivery of the Program. The proposed change will ensure that each Initiation group has at least two (2) Coaches with the Intro to Coach training, while also allowing for on-ice helpers (i.e. parents) to set up drills, etc. and meet the recommended on-ice help to player ratio.

Each player registering with the NOHA shall be required to wear an intra-oral mouthguard during all on ice activities that conforms to the specifications set out by the NOHA and is approved as suitable for use by the team's trainer.

# **Change to Read:**

Each player registering with the NOHA shall have the option to wear an intra-oral mouthguard during all on-ice activities as long as a full-face mask is worn. Should the player elect to wear an intra-oral mouthguard, it must conform to the specifications set out by the NOHA and is approved as suitable for use by the team's trainer.

## **Rationale:**

On several occasions, players have been assessed 10-minute misconduct penalties for failing to properly wear their mouth guard. This rule appears to be used incredibly rarely with the exception of a few officials. The assessment of a misconduct penalty should be reserved for infractions that are detrimental to the game. Children should not be penalized for an inadvertent misuse of a mouth guard during the course of play.

Mouth guards have not been shown to prevent any injury (oral, dental or concussion) in minor hockey where full face guard protection is mandatory.

Many minor hockey associations have made the use of mouth guards optional because of the lack of evidence in injury prevention with full facial protection.

Pierre Lebreque – Sudbury – This was spear-headed by one of our Board members, Dr. Jason Prpic, unfortunately he had to work in the emergency department today. He sent this to read for rationale: "Mouthguards are currently a mandatory piece of equipment for children playing minor hockey in the NOHA, it has occurred on several occasions that children are being assessed ten-minute misconduct penalties for improper wearing of a mouthguard. It's hard to justify this penalty when almost all mouthguards are non-fitting within the first few months of the season. Most children use their mouthguard as a chew-toy in practice and in games, and by the time November rolls around, all the mouthguards are flat pieces of plastic. Furthermore, mouthguards have not been shown to protect against dental injury in patients with full-face masks, and although research into the prevention of concussions is abundant, there is no convincing evidence that mouthguards help prevent the incident of concussions. Several hockey Associations have now made mouthguards a recommended piece of equipment, removing the mandatory nature of their use. Most notably the Ottawa District Minor Hockey Association in

2013, citing a lack of evidence for their use. Sudbury Minor had a committee at the Telus Cup out west, and out of the six Teams, only two were still using mouthguards."

Claudette Myre – Azilda – The NOHA does not support this motion. There are countless amounts of research out there such as the Canadian Dental Association, the American Dental Association, among others, which proves that properly-fitted mouthguards do prevent injuries, in addition concern has been expressed by Hockey Canada about eliminating a risk-management initiative.

**Jim Hall** – **North Bay** – I sat on this committee when we put this together, and I think at this time, can we take a second look at it? I think it's a good program, I think the kids should be tested if they're going to play at that level, and I'm going to ask that we set it aside, try to get another committee going on it, and try to make it work. Testing is important. We need to treat kids in Northern Ontario equally as the kids in the south.

**Mike Creedon** – **Sault Major** – My question is probably best answered by Jason. It would be \$2500 give or take for the Minor Bantam Team, but as the majority of the expense is the travel, would the other two teams be bearing the majority of that cost? For Sault Ste. Marie, for instance, is it \$7500 now between two teams?

**Jason Marchand** – As I explained to the group yesterday, we're looking at a new group for the on-ice testing, and based on that change it would be the same or slightly lower cost regardless of the Minor Bantams, but with the Minor Bantams it would be quite a bit less, roughly \$10 per player plus travel, accommodations, and meals.

**Mike Creedon – Sault Major** – So those other two teams are making a big difference in the cost?

**Jason Marchand** – If you're looking overall, the cost for the program will remain what it has been in the past.

Oscar Clouthier – Sudbury – I speak against the motion. I'd like to give a little history with respect to the off-ice testing. A few years back we formed the Elite Hockey Committee, a group of people from Associations with AAA hockey. We looked at AAA hockey and decided this is what we would do with the elite players playing AAA hockey. I'm totally not against the motion so much as I think it should be referred back to the Elite Hockey Committee for further study, and find out what's wrong and what is right. I'm asking the motion be deferred until next meeting so the committee can look at it.

Andrew MacDonald – Garson – There has been a lot of discussion about the Elite Hockey in Northern Ontario, and if we can have any mechanism in place to help follow the development of the kids, and this gives us a reference point and further information for years to come, and it gives us reference for where the kids fit in overall. This is why these things need to be implemented and carried on so it helps track. There's a lot of criticism to our coaches who put a lot of time in, and we won't have a mechanism to follow what they're doing. This is one of those mechanisms and could be used to show whether a coach is doing a good job. These mechanisms will help us continue to be here for the kids.





Mike Creedon – Sault Major – We had a discussion earlier about dryland and on-ice training, and the Board obviously talked about working on it or putting together another Elite Hockey Committee. Could we also look at a development model where a guy wouldn't have to drive all the way to the Sault? I'm sure we have trainers and coaches who could handle the dryland testing just as well as someone from Toronto, and I'm sure we have people with the equipment to accurately measure on-ice, so that most of the costs will be alleviated because ¾ of the cost is for travel for people to do it. So if there was an online module, someone could learn how to do it. I think this would be the most economically feasible way to do it and still maintain the integrity of it.

**Jason Marchand** – This was also mentioned at the AAA meeting, but for the off-ice testing, there will be two options presented, which will be put forward to the groups. An app has been created through this, so a Coach or Trainer would essentially be able to do this with that app, so depending on which direction we go, there will be a cost. They are still willing to do the training as well, but I know the equipment they use for this is pretty expensive, and I'm not sure if there are any companies in Northern Ontario who do that. Hockey Canada will be reasonable with us when the time comes to finalize the costs.

**Jim Hall** – **North Bay** – I'd just like to add that anything we can do to keep the program running would be great. It's a great program, there was a lot of work put into it. Thank you.

Jacqueline Morvan – Kapuskasing – Since I left the NOHA I have continued to come to the meetings. It's so beautiful to see you still working. You are all fantastic and I really thank you for the time you put in. The NOHA is doing a good job of trying to improve lots of things for you. The lunch today—I think it's a great thing. Lots of people didn't stick around the last few years for awards. I think it's a plus for you guys. The List of Motions, I think it's fantastic. It's a way to know what they worked on and how they worked on it. The presentation booklet they made, don't you think it's great? It's beautiful, it's chic, and you can keep it as a souvenir. They are doing that for you guys. I didn't always agree all the time, but they have to follow the rules. You have to participate; you have to work for hockey because at the end of the day we are here for the kids. It is important that we keep those kids in hockey. I appreciate and thank you NOHA. **Dick Farrow** – **Moderator** – The NOHA Board has nominations to fill for Districts 2, 4, 5, and 8, so if the Association in those areas have someone in mind, they should submit them to the NOHA Board as soon as possible. Next year's meeting will be in Sudbury, and then it will be the 100<sup>th</sup> Anniversary of the NOHA. The first NOHA meeting was held in Cobalt, the 50<sup>th</sup> Anniversary meeting was held in Cobalt, and we're hoping the 100th Anniversary can come back in some part to Cobalt. It's not the same town as it was a few years ago, but hopefully the NOHA Board will grant us permission to bring the 100<sup>th</sup> Anniversary back to its roots in Cobalt.
