Purpose

The purpose of this Handbook is to provide detailed examples and explanations for the application of suspensions. It is not the intention of the NOHA to supersede the OHF Minimum Suspension List, but rather to provide additional documentation and education to our Membership.

We highly recommend that Leagues, Coaches, and Managers keep a copy of this document and become familiar with it so they can work more effectively within the rules and regulations of hockey in the NOHA.

General Guidelines

The NOHA can issue discipline for any action on and off the ice by any NOHA-registered participant that is not covered by Hockey Canada/OHF/NOHA Playing Rules.

The NOHA/OHF Minimum Suspension Guidelines are minimum suspensions. Additional suspensions will be imposed wherever conditions and circumstances warrant.

It is the responsibility of each Team Manager and/or Coach to ensure that their Players serve their appropriate suspensions. If you are in doubt as to the relevant suspension, please get in touch with the NOHA Office (<u>Grant Love</u>). If you are unable to contact the NOHA, sit the player(s) in question out until clarification can be obtained. These suspensions are in addition to the game incurred.

Disciplinary offences on game sheets for any sanctioned NOHA game may only be altered with the approval of the approved process through the Officiating Program Coordinator.

The NOHA shall only address offences occurring in NOHA Regular Season games, NOHA Exhibition games, NOHA Tournaments, and NOHA Playoff games.

The Minimum Suspension guidelines in the NOHA/OHF Minimum Suspension List are the minimum guidelines for the application of a suspension to Team Members.

Example:

A Player receives a 7.6 (c) (Match Penalty for Head Contact) in the second period of a game. The Player will receive a minimum five (5) game suspension; no fewer.

Leagues and Associations may extend the basic suspension(s); however, they shall not reduce the NOHA/OHF Minimum Suspension guideline.

Example:

A Player receives an 8.5 (b) (Major and Game Misconduct for Interference with the Goaltender) in the first period of a League game. It is this player's 2nd Major for 8.5 (b) this season, so the minimum suspension is four (4) games. The League has an extra game for a total of five (5) games as per their policy.

The League decides to add one (1) game suspension to the total to try to curb this type of behaviour in League play. The League is well within their rights to add additional games; however, they cannot reduce the NOHA/OHF Minimum Suspension guideline.

These Minimum Suspension guidelines are to be applied to all Minor Hockey in the NOHA.

The game in which any of the penalties assessed fall under NOHA/OHF Minimum Suspension guidelines shall not be counted in the length of suspension.

Example:

A Player receives a Major Penalty and a Game Misconduct for cross-checking in the second period of a game. The Player is removed from the game and is given a minimum one (1) game suspension. The game the Player is removed from does not count towards the suspension, as the Game Misconduct removed the Player for the remainder of the game in which the infraction occurred.

A Coach receives an 11.2 (e) (Game Misconduct for Abuse of Officials) with four(4) minutes remaining in the third period. The Coach is removed from the game and is given a minimum three (3) game suspension. The game in which the Coach is removed does not count towards the suspension, as the Game Misconduct removed the Coach for the remainder of the game in which the infraction occurred.

It is the responsibility of each Team Manager and/or Coach to ensure the Team Member(s) sit out their appropriate suspensions. It is best to review the code on the game sheet and compare it with the NOHA/OHF Minimum Suspension List. If in doubt as to the relevant suspension, contact the NOHA Officiating Program Coordinator.

Example:

A U13 Team is attending a weekend tournament. On Saturday morning in Game #2 of the Tournament, one of their Players receives a Major Penalty and a Game Misconduct for Slashing in the first period. The Team plays another game that same afternoon. It is the responsibility of the Team Manager/Coach to understand that the Player receives a two (2) game suspension for the infraction.

Suspensions Received in Non-OHF Member Partners (affiliated with HC)

A Participant suspended while playing in an event governed by a non-OHF Hockey Canada partner (e.g., USA, Quebec, HEO, HNO) must serve that suspension during the event, even if it exceeds NOHA/OHF minimums.

Upon returning to the NOHA, a Team will report any suspension received outside of the OHF jurisdiction. The affected Player/Team Official will not be eligible to participate until the report has been received by the NOHA and the NOHA rules on the Player/Team Official's eligibility based upon the NOHA/OHF Minimum Suspension List. It is the responsibility of the Coach/Manager to submit a copy of the game sheet to the NOHA office.

Application Guidelines for Suspensions

Suspensions by the NOHA of any registered Referee, Player, Coach or Team Official may include a provision that will not allow the suspended person to participate in the game of hockey in any capacity. The following guidelines apply:

The suspensions from all aspects of hockey games would apply to all suspensions issued for breach of the NOHA Bylaws and Regulations, as well as all suspensions issued under Hockey Canada/OHF/NOHA Playing Rules 11.2; 11.3; 11.4; 11.5 i), ii), iii), and iv).

Example:

A Player receives a five-game (5) suspension for an 11.4 Discrimination offence. The same Player is also a registered Official. They cannot officiate any hockey games until their five (5) game suspension as a Player is served.

Unless specified otherwise, suspensions resulting from a violation of Hockey Canada/OHF/NOHA Playing Rules will suspend the Referee, Player, or Team Official from participating in the game of hockey in any capacity until the suspension has been served.

While a Player or Team Official is serving their suspension, they may not participate with the Team in any capacity during games.

A suspended Player cannot be present on the Player's bench; however, they are allowed in the Team's dressing room.

A suspended Team Official cannot be present in their Team's dressing room before, during, or following the game(s) they are suspended from or be on the Player's bench.

A Player making a multiple consecutive game commitment of two (2) or more games to the higher-category Team will be allowed to use the remaining games of the commitment as games served for a suspension incurred while participating with this Team. Games shall be served consecutively. The District Council Director is to be advised of the AP Player's commitment before the first game of the commitment.

Match Penalties shall be served with the Player's registered Team.

An Affiliate Player may serve a suspension with the Affiliate Team if their regular Team's season is over, if the following conditions are met.

- The Player is to be listed on the game sheet of the Affiliate Team as serving the number of games suspended.
- They must play in the first game after they have served their full suspension;
- If the Player does not play in the first game, the games that they were listed as an Affiliate Player on the game sheets do not count towards their suspension.

The NOHA will deal with Team Officials who violate this through the appropriate Discipline Guidelines.

A Player/Team Official is suspended until the suspension is served with the team where the

infraction occurred (certified, carded, or Affiliate Team).

Example:

A U15 Player is registered on a U15 team and affiliated with a U18 team. While playing as an Affiliate in a U18 game on Saturday night, they receive a Major Penalty and Game Misconduct for boarding, resulting in a one (1) game suspension. Their U15 Team has a game the next day and on Tuesday. The Player cannot participate in any games with the U15 Team until their suspension is served, as U15 games do not count towards their suspension. The U18 team does not play again until Wednesday, so they will have to miss both U15 games and then sit out the U18 game on Wednesday to serve their one (1) game suspension.

Example:

A U15 Player is registered on a U15 Team in their hometown. They have also been registered on the NOHA U16 team. On February 10th, while playing with Team NOHA, they receive a Major Penalty and Game Misconduct for Head Contact, resulting in a one (1) game suspension. The next Team NOHA game is not until February 18th; however, their hometown team has two League games on February 13th and 15th. The Player cannot participate in any games with their hometown Team until their suspension with the Team NOHA is served, and the hometown games do not count towards their suspension. The player will miss both League games and then sit out the Team NOHA game on the 18th to serve their one (1) game suspension.

If the Team where the infraction occurred has played its last game of the season, then the suspension may be completed with the other Team.

Example:

A U18 Player is registered on the U18 AA Team and affiliated with the U18 AAA Team. On March 3rd, while playing a Playoff game as an Affiliate for the U18 AAA Team, they receive a Gross Misconduct 11.2 (f) resulting in a five (5) game suspension. The Player cannot play any games with the U18 AA Team until they serve the suspension with the U18 AAA team. However, the U18 AAA team lost in the Playoffs on March 6th, ending their season. The Player has served one (1) of the five (5) games necessary for their suspension but can now serve the remaining four (4) games with the U18 AA Team in Playoffs because the Team where the suspension occurred has played its last game of the season.

The Player/Team Official suspension must be listed on game sheets.

The Player/Team Official shall not be included in the maximum number of Players.

Unless noted elsewhere in this document, suspensions cannot be served in Exhibition,

Cancelled, or Forfeited Games.

Example:

A U11 Player receives a two (2) game suspension for a Major Penalty and Game Misconduct for Slashing. The U11 Team's next scheduled League game is a week later; however, after the Player received the suspension, the Coach has scheduled an Exhibition game before that. The Player cannot participate in the Exhibition game, and it does not count towards their suspension. They must miss the Exhibition game and then sit out the next two League game to serve their suspension.

NOTE: Suspended Players can participate in pre-season games during the Development Phase, in accordance with NOHA Regulation 10.2.h.

Example:

A U15 AA Player receives a four (4) game suspension for a Match Penalty in their last game of the season. The following fall, they are trying out for their hometown U15 AA Team. They are allowed to participate in try-outs as well as any Preseason games the Team has scheduled before the Team is rostered and registered with the NOHA. The U15 AA Team's first regular season game is scheduled for October 1st, with two Exhibition games before that. The Player cannot participate in the Exhibition games, and their four (4) game suspension will start on the October 1st League game.

Suspensions may only be served in regular-scheduled League games, NOHA Playoff games or League Playoff games; Exhibition games, and sanctioned Tournaments where entry or scheduling is made before the suspension.

Example:

A U18 Player receives a six (6) game suspension on December 21st for their third Major Penalty and Game Misconduct. Over the Christmas break, the U18 Coach discovers an additional Tournament for the Team to attend on January 8-10. The Team has three League games between Christmas and January 8th. The Player will be able to serve three (3) of their six (6) game suspensions. However, because this Tournament was not scheduled before the Player received their suspension and has not yet served the entirety of it, they are unable to participate in the Tournament. The games do not count towards their suspension.

Suspensions for violations of the Hockey Canada/OHF/NOHA rules and regulations must be served in the next game or games the Player/Team Official participates in.

Suspension for violation of League/Tournament rules (i.e. accumulation of penalty minutes; misconduct; game misconducts; fighting majors; CFBs; HC's; etc.) may be implemented at the discretion of the League/Tournament.

Example:

The Minor Hockey League has a League rule in the U15 and U18 divisions that states, "Any Player that reaches fifty (50) penalty minutes in the season will receive an automatic one (1) game suspension". The League can implement this suspension in addition to any NOHA minimum guidelines.

Any suspension imposed upon any Player, Coach, or Team Official by the Officials of any League, Association, or Tournament registered with NOHA shall be given full recognition by the NOHA.

Record Keeping of Suspensions

All registered Teams under the NOHA must submit a copy of all correspondence involving suspensions received when playing outside the NOHA to the NOHA Office (<u>Grant Love</u>). within 24 hours of the suspension.

All registered Teams under the NOHA must submit a copy of all correspondence involving suspensions received when playing a game within the NOHA to the NOHA office (<u>Grant Love</u>) that is not recorded in the Gamesheet program.

All Teams must abide by the NOHA/OHF Minimum Suspension guidelines.

It is the responsibility of Teams to ensure they track suspensions. Do not rely on the Gamesheet program.

Rule 11 - Maltreatment

Discrimination 11.4

Any Player, Coach, Manager, or Team Staff assessed a penalty under Rule 11.4 of the Hockey Canada Rule Book is to be indefinitely suspended until the outcome of a hearing with the NOHA.

Policy:

Physical Abuse of Officials 11.5

Any Player, Coach, Manager, or Team Staff assessed a penalty under Rule 11.5 of the Hockey Canada Rule Book is to be indefinitely suspended until the NOHA Chair of Discipline deals with the matter.

Accumulation Sanctions

Any Player, Coach, Manager, or Team Staff assessed a second (or additional) Rule 11(Maltreatment) penalty in the same season of the Hockey Canada Rule Book is to be indefinitely suspended until the outcome of a hearing with the NOHA. The exception to this is Rule 11.1(e). For 11.1(e), the indefinite suspension and hearing are for the third (or additional) offence.
