
Re: Freedom of Movement Survey Results

The NOHA Board of Directors very much appreciates the feedback that we received from more than 1800 families across the NOHA regarding their thoughts on freedom of movement within our jurisdiction. This represents approximately 20% of the membership – thank you to all who took the time to provide their feedback!

Out of more than 1800 responses, including approximately 2500 players, more than 74% of respondents support freedom of movement within the NOHA, while 19% do not support and another 6% are unsure.

Do you feel that your child(ren) should be able to register with whichever Association within the NOHA that they desire? In other words, do you support freedom of movement within the NOHA?




Nickel City – 144 responses, 84.7% in favour;

Feedback by Division

The survey received strong responses for all age divisions, with a fairly even breakdown across all divisions. U11 and U13 each received over 25% of the total responses.

Feedback by Category

Not surprisingly, more than half of the responses received were from parents involved with House League programming. 57% of respondents were from this category, with 73% of them in support of freedom of movement.

NOHA Position

The NOHA Board of Directors previously shared its position on freedom of movement in November, 2022, and we continue to support not only based on the data provided, but also based on the following rationale:

- It is the position of our Board that families should have the choice of where they register their child in programming;
- It is also the position of the Board that Players being allowed to participate in the program of their choosing will benefit recruitment and retention of Players;
- The NOHA is the only Member Partner in the OHF that does not have freedom of movement at House League/Recreational Hockey;
- While we now have all AA Teams competing in the same League, we have had Associations not provide releases to Players wishing to compete at a higher level and subsequently they played "A" when there were other opportunities to play AA within another Association;
- The majority of appeals received by the NOHA are requests for releases. While most families have valid reasons, such as work, or requiring family support to bring their Player to practices/games, the Appeals Committee generally has supported the NOHA Constitution and subsequently, our Minor Hockey Associations;
- There are several Associations in the NOHA who have their own internal agreements, which allows for a form of freedom of movement. Some examples include,

- Timmins and Porcupine
 - Copper Cliff and Sudbury
 - Soo Peewee and Sault Major
 - Manitoulin Minor Hockey
 - Blind River and Elliot Lake
 - Hearst and Kapuskasing
- There have been multiple situations where the NOHA has been compelled to resolve disputes between Associations due to issues surrounding the movement of Players. As a Board, we feel that this is an inefficient use of the NOHA Board's time as well as that of our Associations. Freedom of movement will allow the Board to focus on other issues.

We are looking forward to a fruitful discussion at the NOHA Annual General Meeting, being held in Timmins on May 6, 2023.
